## CAAs Receiving Funding

## ***New York State Census Equity Fund Awards \$1.4 Million to Community Organizations for 2020 Census Outreach***

This month, the New York State Census Equity Fund announced its second round of grants, totaling \$1,437,000, to 56 organizations to support efforts across the state to reach hard-to-count communities in the 2020 Census. Historically, some populations—including communities of color, low-income households, immigrants, rural households, and young children—have been under-counted in the census. Nonpartisan experts agree that getting an accurate count in 2020 will be especially difficult.

Several Community Action Agencies are among the organizations to receive the grant funds to ensure the hard-to-count populations in their communities are accurately represented in April's 2020 Census. [Pro Action of Steuben & Yates](#), [Cattaraugus Community Action](#), [Opportunities for Otsego](#), and [Westchester Community Opportunity Program](#) will receive funds in this round of grants. ## **Census 2020**

### ***How Do I Take the 2020 Census?***

By April 1, 2020, every home will receive an invitation to participate in the 2020 Census. You will have three options for responding: online, by phone, or by mail.

The Census Bureau has also released a PSA Toolkit which enables partners and stakeholders to access produced PSAs or create their own using pre-approved messages. PSAs are an effective way to educate the public about the importance of the 2020 Census and why participation matters.



### ***Is My 2020 Census Data Safe?***

The U.S. Census Bureau is bound by law to protect your 2020 Census responses and keep them strictly confidential. In fact, every employee takes an oath to protect your personal information for life.

## CSBG National Partner Resources

### ***CAPLAW - It's Beginning to Look a Lot Like...Bonus Season? Managing Disallowance Risk in Incentive Compensation Policies and Practices***

Community Action Agencies (CAAs) considering [one-time incentive compensation or bonus payments](#) to their employees must pay attention to both the content and the implementation of incentive compensation policies. While federal tax and grant rules permit CAAs to pay incentive compensation, improper practices have led to significant disallowances, penalties, and even the revocation of tax-exempt status.



CAPLAW has provided a review of the incentive compensation rules applicable to CAAs, discusses issues to consider when drafting a policy, and describes how to implement a policy to mitigate the risk of disallowance.

### ***CAPLAW - Complying with the New Overtime Rule Under the Fair Labor Standards Act***

A new federal overtime rule that will increase the number of employees eligible for overtime pay goes into effect on January 1, 2020. To help CAAs understand the changes and potential workplace impacts, CAPLAW is issuing the FAQ, [Complying with the New Overtime Rule Under the FLSA](#).



In light of the complexity of issues arising under the federal FLSA, and as a refresher for CAAs, CAPLAW has updated its [Overview of FLSA Principles FAQ](#) covering the requirements of the FLSA and its applicability to CAAs. Together, these resources can help CAAs navigate the new overtime rule and maintain compliance with the FLSA.

***Fiscal Policy Institute - The Unequal State of New York***

The Fiscal Policy Institute reports that New York State has the most unequal income distribution in the nation, with the fewest people capturing the greatest share. Not since the “Gilded Age” of the 1920s has our state seen such a vast divide between the highest- and lowest-income New Yorkers; and without intervention, that gap is expected to continue growing.



New York is a particularly extreme example, but rising inequality is a problem across all areas of the nation. Now is our chance to reverse the trend and lead the country by adopting sound economic and social policies that promote growth and development for the many rather than the few so that all New Yorkers have an equal chance at opportunity. ### ***The Annie E. Casey Foundation - Children Living in High-Poverty, Low-Opportunity Neighborhoods***

Living in areas of concentrated poverty — and missing out on safe and healthy opportunities to learn, play and grow — is a reality for more than 8.5 million kids in America today. Policy makers, businesses, and philanthropic leaders must act now to boost housing options and spur economic growth for the families who call these communities home.



This snapshot shares the latest data — for the nation and each state — on children growing up in high-poverty areas. It also singles out two important factors, geographic location and race and ethnicity, that shape a child’s risk of living in concentrated poverty. ### ***Head Start, Public Schools Partnership to Strengthen Transition to Kindergarten***

A new effort to support America’s earliest learners was launched this month. The Office of Head Start (OHS) at HHS’ Administration for Children and Families formalized partnerships with the National Association of Elementary School Principals (NAESP) and the School Superintendents Association (AASA) to improve the transition of Head Start children as they enter elementary school. These partnerships were formalized with a memorandum of understanding with [NAESP](#) and [AASA](#), and were signed at Higher Horizons Head Start & Early Head Start in Falls Church, Va.

### ***Bloomberg Opinion - LBJ's Great Society Won the War on Poverty***

"In 1964, President Lyndon Johnson called for the U.S. to become a “great society.” That term came to be synonymous with the Johnson administration's War on Poverty. The Great Society initiative led to the creation of Medicare and Medicaid, the modern version of food stamps, Head Start, various jobs programs, expansion of many kinds of Social Security benefits, urban-renewal spending and a vast array of other social programs.



Many now believe this War on Poverty was a failure. Among conservatives, it’s almost an article of faith that LBJ's welfare state fostered a culture of dependence that trapped people in the very poverty it was meant to eliminate.

Meanwhile, many also feel a sense of frustration that poverty is still with us, stubbornly stuck at about a seventh of the population." [Click here](#) to keep reading.
